Sail Training booking form

Conditions of Booking

1. Courses usually commence at Dunstaffnage marina, by Oban, although on certain courses, the actual time and place may be determined when you book and confirmed prior to the trip.
2. All bookings must be confirmed in writing. Telephone bookings will be held for ten days until a completed booking form and a 25% deposit is received. The full balance is due eight weeks before the departure date. Bookings for three or more sail training candidates will be confirmed on receipt of deposits. Bookings of less than three sail training candidates may require alternative dates and will be confirmed or alternatives offered 30 days before the date concerned. If FOLSS is not able to make up a satisfactory crew, deposits will be refunded.
3. Cancellations. Clients cancelling their course more than eight weeks prior to their trip will forfeit only the 25% deposit. Clients cancelling less than eight weeks before their trip will be liable for all the unpaid balance. Cancellations must be made in writing. **Therefore passengers are required to have their own personal and travel insurance policy for the trip including cover for "sailing outside coastal waters" if on an extended training course.**
4. FOLSS carries third party insurance for sail training beyond which no liability for any injury, loss or damage to personal items, loss due to cancellation or any delay caused by adverse weather conditions will be accepted. All participants accept the activity presents inherent risks.
5. We reserve the right to cancel any trip if due to circumstances beyond our control we are unable to provide the course concerned. In such case we will refund all monies paid and clients will have no further claim.
6. In matters concerning the safety and operation of the vessel the decision of the skipper will be final. Courses require participants to carry out the duties allocated in operating, running and maintaining the vessel.
7. **Smoking is not allowed below decks.**
8. Included in the price are; all services, meals taken on board, accommodation, fuel.
9. Not included: transport to/from the point of embarkation/disembarkation, travel insurance, marina or berthing charges incurred during the period of the course.
